44th Sanremo Round Table on Current Issues of IHL







The International Institute of Humanitarian Law, in co-operation with the International Committee of the Red Cross, organised its annual Round Table focusing on "Pandemics, armed conflict, and international humanitarian law". The event, held online in the form of a webinar series from 6th to 15th September, counted 2438 registrations.

The opening session started with an introduction delivered by Professor Edoardo Greppi, President of the Institute, and Dr Helen Durham, Director of International Law and Policy at ICRC. Their remarks were followed by the key-note messages released by Benedetto Della Vedova (Italian Ministry of Foreign Affairs and International Cooperation), Dr Esperanza Martinez (ICRC) and Dr Michael Ryan (WHO).

Prof. Fausto Pocar, Honorary President of the Institute, commented on the Resolution adopted by the "Institut de Droit International" on "Epidemics and International Law" drafted by the Rapporteur Shinya Murase. This topic led to a discussion chaired by the President, between Lt. Gen. Dennis Gyllensporre (MINUSMA) and Dr Cordula Droege (ICRC), addressing the topic of "Legal and operational challenges arising in armed conflict in times of pandemic".

Session 2, held on 8th September, offered an overview on "The provision of medical care in times of armed conflict", and was chaired by Brig. Keith Eble (UK). The first intervention was delivered by the Deputy Director of the Military Department (IIHL) Capt. Jean-Emmanuel Perrin (French Navy) and focussed on the issue of "Legal and operational challenges for the provision of health care during armed conflict and pandemics". The following interventions were delivered by Brig. Gen. Mohammad Sumon Reza, who explained the ICRC Guidelines for Military on Protection of Healthcare, and Dr Sandrine Tiller (Médecins sans Frontières), who faced the topic of misinformation and disinformation circulating during pandemics.

The 3rd webinar was held on 13th September and hosted Ms Nancy Polutan-Teulieres (Policy and Standard Setting Lead, GPC), Prof. Giulio Bartolini (Roma Tre University) and Dr Naz Modirzadeh (Harvard Law School Program on International Law and Armed Conflict). The session, attended by 252 participants and chaired by Ambassador Marja Lehto (Finland), focussed on "The role and challenges of humanitarian actors in providing aid and assistance to populations affected by armed conflict and pandemic".

The closing session took place on 15th September and was chaired by Camille Faure (French Ministry of Armed Forces) who hosted Dr Sandra Krähenmann, Thematic Legal Adviser at Geneva Call, and Dr Tilman Rodenhäuser, (LegAd, ICRC). The panellists addressed the crucial issue of "The protection of persons living in areas beyond state control and the role of non-state armed groups in addressing the pandemic". The event was concluded with some closing words delivered by Dr Durham and Prof. Greppi.

A total of 1119 individuals participated in this 44th edition, which hosted 22 speakers and was split into 4 sessions. All the webinar series were recorded and are now available on the IIHL webpage dedicated to the event: https://iihl.org/44th-sanremo-round-table/.

Visit of the Taiwan delegates to the Institute

G20 Interfaith Forum 2021

On Tuesday 14th September, Professor Edoardo Greppi represented the Institute at the Focus Session of the G20 Interfaith Forum on the topic "Mediterranean Sea: Frontier of Peace".

Prof. Greppi presented the activities carried out by the Institute from its foundation in 1970 to the present day. In fact, following its main purposes of disseminating and promoting IHL and related issues, the Institute has organised hundreds of courses involving more than 20.000 participants since 1976. Fifty years of international meetings and intense training activity have created what has universally become known

as the "humanitarian dialogue in the spirit of Sanremo". Following this aim of inclusion and intercultural integration, the Institute began to be involved in certain European Union funded projects concerning the field of peace education. On 31st May 2021 the Education Inspiring Peace Laboratory (EIP Lab) was formally established as a concrete follow up to the Upper Project, that is directly linked to the other projects in which the Institute is a partner. According to its aims, EIP Lab was mentioned as a key element for a long-term peace dialogue in the Mediterranean.




The second edition of the LDEs course was composed of 3 modules addressing respectively Targeting, New Technology, and Cyber. In contrast with the last edition of the course, Module 2 was completely redesigned to provide participants with a deep understanding of the mechanisms of the review of weapons regulated in art.36 of the Additional Protocol I to the Geneva Conventions. The ten practitioners and military personnel who participated in the course particularly appreciated the "open forum" exercise format, which allowed them to share their opinion as well as their personal experiences in order for the class to solve the scenario's problems. The teaching staff, coming from 7 countries, contributed to the internationalization of the debates carried on during the course and was composed of: Col. 3rd IHL in Depth Online Course

20th September - 27th October

The latest edition of this course started on 20th September. Participants had already faced the first Module concerning the IHL principles to be respected during the targeting process and solved the exercise delivered through the breakout rooms format. Each room was composed of 9 and 8 people and was respectively led by Col. Dakers and Lt. Col. Blake Williams, with the participation of Dr Martha Bradley (South Africa), who gave some input to both the classes. During the following 4 weeks, participants will address 5 thematic Modules specifically dedicated to jus in bello principles and practice, the relationships between IHL and human rights, partnered operations and future perspectives.



Targeting Course

27th September - 1st October

This course marked the introduction of onsite courses in Sanremo after the pandemic. Fifteen participants from – countries gathered in Villa Ormond and completed the training. The teaching staff, half on site and half participating in online zoom sessions, was composed of Col. Mark Dakers, (Course Director), Maj. Peter Rasmussen (Deputy Course Director), Prof. Françoise Hampson (UK), Air Comm. (ret) Dr William Boothby (UK), Lt. Col Blake Williams (USA) and Flight



Lt. Dominic MacAleese (Royal Air Force), and Maj. John Griffiths (UK). This specialised course made participants aware of the main IHL principles governing the targeting process and allowed them to have an overview of some realistic situations which could happen in military operations, and work together on the realistic scenario designed by the IIHL staff.

10th Online Course on International Refugee Law (Arabic)

21st June - 16th July 2021

The 10th Online Course on International Refugee Law was developed by the Department of International Refugee Law and Migration Law in cooperation with the United Nations High Commissioner for Refugees, the State Secretariat for Migration of the Swiss Government, and the United States Department of State - Bureau of Population, Refugees, and Migration. The Course, which was delivered in Arabic, welcomed 39 participants from 14 different countries. Among the participants were government officials and members of civil society. including staff from non-governmental and international organisations, researchers and members of the academia.

The Course explored crucial aspects of the international protection of refugees, which included the phases of displacement and associated risks, the causes that force people to flee, and the search for and implementation of durable and sustainable solutions. A cross-cutting approach was adopted to analyse gender-based violence and protection needs of stateless and internally displaced persons. Throughout the Online Course, the complementarity of other bodies of law with international refugee law was also examined with the purpose of highlighting how the safeguard of the human rights of refugees was not only linked to the 1951 Convention on the Status of Refugees. The Course featured live, interactive and self-paced sessions delivered by experts on refugee protection topics, utilizing a variety of training methodologies, such as case studies, quizzes, and the sharing of theory and practice. These sessions, combined with the submission of individual assignments. provided for a learning experience that was dynamic and suitable for professionals.

The Course was directed by the Director of the Department of International Refugee Law

and Migration Law, Mr Claudio J. Delfabro D., coordinated by Mr Rasem Draou, Assistant Project Coordinator of the Department, and featured the presence of Ms Lobna Abdel Hadi, International Consultant on Refugee Protection, who acted as Lead Facilitator during the training. The Course was enriched by the presence of Ms Shaden Khallaf. Head of the Middle East and North Africa Policy Unit at UNHCR, who kindly delivered the keynote address on forced displacement in the current era and worldwide. 


11th Online Course on International Refugee Law (Spanish)

21st June - 16th July 2021

The 11th Online Course on International Refugee Law was developed by the Department of International Refugee Law and Migration Law in cooperation with the United Nations High Commissioner for Refugees, the State Secretariat for Migration of the Swiss Government, and the United States Department of State - Bureau of Population, Refugees, and Migration. Forty-eight participants from 15 different countries benefitted from the virtual training, which was delivered for the first time in Spanish. The participants ranged

from government officials to members of civil society, including non-governmental organisation and international organisation staff, as well as researchers and members of the academia.



The Course, which focused on Latin America, explored crucial aspects of the international protection of refugees, including regional legal framework established by the 1984 Cartagena Declaration and the Inter-American System for the Protection of Human Rights. Throughout the Online Course, the complementarity of the legal instruments with international refugee protection and the extent to which the rights of refugees were protected and respected were also examined. A transversal approach was adopted to analyse problems related to refugees such as: trafficking in persons, and smuggling of persons, mixed movements, gender-based violence, and the protection of stateless persons and internally displaced The Course applied various training methodologies such as studies, quizzes and the sharing of theory and practice during its live and self-paced sessions. Such methodologies together with the submission of individual assignments, allowed participants to take part in a dynamic learning experience.

The Course was directed and facilitated by the Director of the Department of International Refugee Law and Migration Law, Mr Claudio J. Delfabro D., and coordinated by Ms Clara de Haro Arbona. Associate Coordinator of the Department, with the support of Ms Amaya Lyne, Project Assistant of the Department. On the occasion of the Opening Session, the Department and all its team were honoured by the participation of Mr Filippo Grandi, the High Commissioner for Refugees, who welcomed the participants through a dedicated video message. The Course was also opened by Mr Fausto Pocar, Honorary President of the Institute and Ms María Bances del Rey, Chief Protection Officer, UNHCR Regional Office for the



Americas, who kindly delivered the keynote address on Forced Displacement Situation in the Americas, that has now reached historic levels due to the confluence of various humanitarian crises. 1st Online Course on Statelessness (English) 21st June - 16th July 2021

The 1st Online Course on Statelessness was developed by the Department of International Refugee Law and Migration Law and delivered in English. The Course, which took place from 21st June to 16th July 2021, welcomed 52 participants from 38

countries around the world. The Course was attended by government officials as well as members from civil society organisations, non-governmental organisations and international organisations. The Course was made possible thanks to the contribution and support of the United Nations High Commissioner for Refugees and the United States Department of State - Bureau of Population, Refugees, and Migration.

The Course delved into the adoption of international conventions on statelessness and development of national legislation, and work with stateless persons in the field. Using a combination of theory and practice, facilitators shared tools, good practices and tips. The Course analysed the causes and impacts of statelessness, the overview of stateless populations around the world, including stateless children, and the interrelation between statelessness and forced displacement. The Course utilized interactive, live sessions and self-paced sessions, allowing participants to engage in thoughtful discussions, while also taking the time to develop a thorough understanding of the issues surrounding statelessness.



The 1st Online Course on Statelessness was directed and facilitated by the Director of the Department of International Refugee Law and Migration Law, Mr Claudio J. Delfabro D. and coordinated by Mr Kristijan Mihajlovski, Coordinator Academic Unit of Department, with the support of Ms Amaya Lyne, Project Assistant of the Department, and Ms Abigail Stoffer, Junior Collaborator of the Department. During the first session, participants were welcomed by Professor Edoardo Greppi, President of the Institute. Ms Melanie Khanna, Head of Statelessness Section in the Division of International Protection at UNHCR then delivered the keynote address where she highlighted the current situation of statelessness worldwide. Course 1 on the Specialization Program on Protection Coordination (English)

28th June - 10th September 2021



The Specialization Program on Protection Coordination (SPPC) is a learning programme organized by the Global Protection Cluster and its different areas of responsibility in cooperation with the Department of International Refugee Law and Migration Law of the International Institute of Humanitarian Law. Course 1 of the Programme welcomed 25 participants from 14 countries around the world. The Programme was developed for co-coordinators, and local actors to strengthen their skills needed for effective Protection Coordination and to encourage a collaborative and harmonized protection response. The Programme utilizes not only self-paced and live, interactive sessions but also a dedicated phase for participants to work with mentors on a project that helps them implement the skills and knowledge they have gained.



12th Online Course on International Refugee Law (English)


5th- 30th July 2021

The 12th Online Course on International by Refugee Law was organised Department of International Refugee Law and Migration Law in cooperation with the United Nations High Commissioner for Refugees, the State Secretariat for Migration of the Swiss Government, and the United States Department of State - Bureau of Population, Refugees, and Migration. The Course, which was delivered in English, welcomed 55 participants from 31 different countries. The pool of participants was of government composed officials, members of civil society, including staff from non-governmental and international organisations, as well as researchers and members of the academia.



The Course examined key elements of the international protection of refugees and covered a range of issues, including the causes that force people to flee, the protection risks encountered through the displacement cycle, and the search and implementation durable and sustainable solutions. Throughout the Online Course, International Refugee Law was critically analysed and its complementarity with other bodies of law regarding the different displacement phases was explored. A cross-cutting approach was adopted to analyse problems related to refugees such as: gender-based violence and the protection of stateless persons and internally displaced persons. Over the span of four weeks, participants took part in live, interactive sessions and self-paced sessions delivered by experts on refugee protection topics. The sessions, which included the submission of individual assignments from participants, utilized case studies, quizzes, and the sharing of theory and practice to ensure an effective learning experience.

The Course was directed and facilitated by the Director of the Department of International





4th Online Course on Internal Displacement (French)

30th August - 24th September 2021


The 4th Online Course on Internal Displacement was developed by the Department of International Refugee Law and

Migration Law in cooperation with the United Nations High Commissioner for Refugees, the Office of the UN Special Rapporteur on the Human Rights of Internally Displaced Persons, the Swiss Federal Department for Foreign Affairs, and the United States Department of State - Bureau of Population, Refugees, and Migration. The Course, which was delivered in French, welcomed 34 participants from 15 different countries. The cohort of participants was composed of government officials and members of civil society, including staff from non-governmental and international organisations, as well as members of the academia.



The Course explored key aspects of the protection of IDPs, while analysing internal displacement from different angles and perspectives. By adopting a cross-cutting approach, issues such as: housing, land and property, data collection, and the international community coordination mechanisms established together with State authorities and civil society representatives to respond to IDP situations, were analysed. The workshop ultimately addressed the search and implementation of durable and sustainable solutions for IDPs. Course was directed by the Director of the Department of International Refugee Law and Migration Law, Mr Claudio J. Delfabro D., coordinated by Ms Clara de Haro Arbona, Associate Coordinator of the Department with the support of Mr Rasem Draou, Assistant Project Coordinator of the Department. Professor Edoardo Greppi, President of the Institute, welcomed the participants through an appropriate video message. Ms Cecelia Jimenez-Damary, Special Rapporteur on the Human Rights of Internally Displaced Persons, kindly delivered the keynote address during the first session of the Course. 
5th Online Course on Internal Displacement (English)

30th August - 24th September 2021

Online The Course on Internal Displacement was developed by the Department of International Refugee Law and Migration Law. It was developed with the continued support of the United Nations High Commissioner for Refugees, the Office of the UN Special Rapporteur on the Human Rights of Internally Displaced Persons, the Swiss Federal Department for Foreign Affairs, and the United States Department of State - Bureau of Population, Refugees, and Migration. The Course, which was delivered in English, welcomed 49 participants from 20 different countries. The participants ranged from government officials members of civil society, including staff



from non-governmental and international organisations, as well as members of the academia.



This Online Course examined the international norms underpinning the protection of internally displaced persons, including the Guiding Principles on Internal Displacement and the Kampala Convention. It also adopted a cross-cutting approach to examine issues such as housing, land and property, data collection, and the international community coordination mechanisms established to respond to internally displaced persons' situations, while ultimately addressing the search and implementation of durable and sustainable solutions. The Course was directed and facilitated by the Director of the Department of International Refugee Law and Migration Law, Mr Claudio J. Delfabro D., coordinated by Ms Clara de Haro Arbona, Associate Coordinator of the Department with the support of Mr Rasem Draou, Assistant Project Coordinator of the Department. Participants were welcomed by Professor Edoardo Greppi, President of the Institute, through a dedicated video message, with Ms Cecelia Jimenez-Damary, Special Rapporteur on the Human Rights of Internally Displaced Persons, delivering the keynote address during the first session. Summer School on Refugees, Migration and the "New Normal" at the Refugee Law and Migration Centre – Skopje, North Macedonia 24th August 2021



The Director of the Department of International Refugee Law and Migration Law, Mr Claudio Delfabro, and the Academic Unit Coordinator of the Department, Mr Kristijan Mihajlovski, were invited as speakers for the Refugee Law and Migration Centre's Summer School of the University Saints Cyril and Methodious to facilitate the session on "Refugees and Other Persons in Need of Protection".

Through a mix of theory and practice, such as case studies, and guided discussions, the interactive session examined the complexity of mixed movements and enabled participants to get familiarized with and distinguish among the main categories of persons on the move, such as refugees, stateless and internally displaced persons, and trafficked and smuggled people. This allowed the class to approach important definitions at an introductory level, also through an in-depth analysis of the components of the refugee definition, and to align their understanding with key elements of each topic.

Uniting Business Live by the UN Global Compact

20th - 22nd September 2021

The Director of the Department International Refugee Law and Migration Law, Mr Claudio J. Delfabro D. was recently invited to Uniting Business Live organised by the UN Global Compact. Over the course of three days, the event attracted more than 7,000 registered participants from 143 countries for four high-level events: Private Sector Forum, Global Impact Forum, Young SDG Innovators Summit and the SDG Business Forum. Many high-level speakers including Heads of State from Denmark, Fiji, Germany, Kenya, Norway, Spain and Sweden, the Vice-President of Nigeria, several Ministers, the President of the UN General Assembly, the UN Secretary-General, and more than 30 CEOs from the world's leading sustainable companies, took part in the event.



21st Summer Course on International Humanitarian Law

(9th - 23rd July 2021)

The 21st Summer Course of the International Institute of Humanitarian Law successfully held for the second year online. Twenty-five participants from 16 countries were able to deepen their knowledge of international humanitarian law, refugee law and human rights law, through a comprehensive approach to the various issues inherent to armed conflicts, and to interact with world-renowned practitioners, and academics. **Participants** experts attended 27 sessions, the equivalent of 30 hours of classes, at a rate of 3 hours per day. The different daily sessions were held in two parts, with a documented contribution from the speakers and a time for questions and answers. This interactivity, beneficial to all, allowed the professionals and students following such course to exchange views with international specialists and high-level

experts and present their perspectives and experiences. The Institute is committed to offering a real interaction between practitioners and participants and invites them to give their feedback after each session.

To complement these different sessions, participants were able to access the Institute's online learning platform - a handy tool at their disposal - which allows them to view specific recordings, obtain additional documents and ask further questions to the speakers. Accessible for an unlimited period of time, this platform also offers the Institute's news as well as a digital library of international law.

The entire course allowed participants to deepen and consolidate their knowledge of international humanitarian law through a global and multidisciplinary approach integrating international criminal law, human rights, and migration law. Through the examination of existing cases this course helped clarify the application of the different bodies of law in the context of armed conflicts and humanitarian operations (see Programme - Annex 1).



At the end of the 21st Summer Course on International Humanitarian Law, the participants were awarded a certificate attesting to their participation and attendance by a recognized centre of excellence.

This multicultural course, which brought together 25 participants from 16 countries from all over the world (see List of participants - Annex 2) wishing to strengthen their knowledge of the problems inherent to human security in the context of armed conflicts and international migrations, gave rise to exciting exchanges, rich in lessons learned.

Workshop on "Women and Law Enforcement in Conflict and Post-Conflict Situations: Guidelines and Rules"

(20th August – 17th September)

The Workshop on "Women and Law Enforcement in Conflict and Post-Conflict Situations: Guidelines and Rules" was delivered in Spanish in b-learning modality.

This Workshop is part of the project "Women and law enforcement in conflict and post-conflict situations: guidelines and rules" that the Institute - through the Special Projects and Training Activities for the Latin America sector - is developing with the collaboration and financial support of the Italian Ministry of Foreign Affairs and International Cooperation. The support of the Ministry is provided in the framework of the "Fourth National Action Plan adopted in compliance

with Resolution no. 1325 (2000) of the United Nations Security Council on Women, Peace and Security and subsequent resolutions", generated under the supervision of the Interministerial Committee for Human Rights (CIDU).

The online Workshop aimed to generate the necessary inputs for the drafting and presentation of guidelines, rules and guidelines on gender mainstreaming in the institutions of the security forces regarding their actions and obligations in situations of armed conflict, other situations of violence and post-conflict, as well as recommendations regarding good practices for forgiveness and reconciliation in post-conflict situations.

The Workshop included 4 Modules developing the following topics: Gender Perspective, Women and Law Enforcement, Women, Peace and Security and Forgiveness - Reconciliation.

The specific objective of each thematic module was to generate a document related to the topic addressed.

There was a total number of 28 participants from 10 different Latin American and European countries.

Updates on new projects proposals submitted to the European Union

During the summer period, the Institute actively contributed to the elaboration of a project proposal for the 2021 Autumn ERASMUS+ call together with a project proposal within the Citizens, Equality, Rights and Values Programme (CERV).

In the framework of the ERASMUS+ programme "Alliance for Innovation -Alliances for Education and Enterprises", the



Institute submitted, as coordinator, the project proposal "Conflict Transformation Competences for Peace Jobs and Life COMP4PEACEJOBS". Coordinated Institute, the partnership of the proposal is COMP4PEACEJOBS project composed by Université Côte d'Azur (France), Vienna Forum for Democracy and Human Rights/Polis - The Austrian Centre for Citizenship Education in Schools, Universitatea Politehnica din Bucuresti (Romania), Interprofessionelle Auvergne Rhône Alpes (France), CIS Formazione (Italy), Unione Cristiana Imprenditori Dirigenti (Italy), Organización Iberoamericana de Seguridad Social (Spain), Forum des Régions Européennes pour la Recherche, l'Education et la Formation (France), Universidad de Guadalajara (Mexico), Universidad Santo Tomás (Colombia), Centro de Estudios Sociales y Jurídicos del Ecuador, Softtehnica SRL (Romania), Pôle emploi Auvergne-Rhône-Alpes (France). The main objective of the COMP4PEACEJOBS project is to boost curriculum and methodological innovation within and between vocational education and training (VET) and higher education institutions, particularly by stimulating the integration of structured peace competences modules in study programmes and initiatives addressed not only to classic "peace workers", but also to other relevant professional categories.

With reference to the Citizens, Equality, Rights and Values Programme of the European Union, the Institute collaborated to the elaboration of the "Policies with Adolescents: Reviving and Sustaining of Agency through Digitalisation, Education and Socialisation – PARADES" project. The project is coordinated by the University of Modena and Reggio Emilia (UNIMORE), and, in addition to the Institute, it brings together a consortium consisting of Cooperativa Cosmo, the Municipality of Sanremo and the Organising Bureau of European School Student Unions – OBESSU (based in Belgium). The project aims

at enhancing and supporting the agency of adolescents (aged 12-17) who, during the pandemic, have been mainly excluded from schools, informal gatherings, cultural life, and any decision concerning their needs and proposals.

During the month of August, the Institute was also informed about the approval of the project proposal Must-A-Lab, proposed during February 2021 within the EU call for proposals "AMIF - Transnational Actions on Asylum, Migration and Integration". The partnership of Must-A-Lab includes the Municipality of Mechelen (acting as coordinator), the University of Modena and Reggio Emilia (UNIMORE), the Municipality of Modena (Italy), the Karel de Grote Hogeschool (Belgium), the Sanremo Institute, the Municipality of Fuenlabrada (Spain), the Municipality of Livadia (Greece), the District of Neubau, Vienna (Austria), the Municipality of Pont-de-Claix (France), the Forum des Régions Européennes pour la Recherche, l'Education et la Formation (France). The project will aim at improving local integration strategies through the systemic and longterm involvement of stakeholders in cities and communities through the methodology of Policy Labs (PLs), starting from January 2022.

1st Assembly of Members of the Education Inspiring Peace Laboratory

The first Assembly of Members of the Education Inspiring Peace Laboratory, hosted

by the Institute, was held at Villa Ormond.

The first part of the Assembly consisted of the formal admission of institutional and individual members of the Laboratory and the election and appointment of its institutional bodies. In this regard, Professor Edoardo Greppi, already appointed as President at the moment of the legal constitution of the association, was confirmed in his role, while Ms Christiane Demontés, President of the Forum des Régions Européennes pour la Recherche, l'Education et la Formation, was elected Vice-President, and Mr Gian Luca Beruto (IIHL) and Mr Mauro Giancaterino (IIHL) were confirmed as Director and Treasurer respectively.

The Assembly of Members furthermore established the Executive Council of the Laboratory, a key operational body whose primary task is to assist the institutional bodies in performing their steering functions. The institutional session of the Assembly was then followed by an operational session, during which the 2022 work plan of the Laboratory was discussed with the contribution of all the members. More precisely, during this operational session members analysed the five work areas of the Laboratory, namely Practice, Research, Institutional Consolidation, Policy and Communication. For each of these areas, the actions already implemented in the past year were explored and the programme for 2022 was presented.
