## Learning objectives

The Online Course on Cultural Property Protection (CPP) is organized by the Sanremo Institute's **Special Projects Department**, with the financial support of Fondazione Compagnia di San Paolo and in association with the <u>Master in Cultural Property</u> <u>Protection in Crisis Response</u> of the University of Turin.

It aims to equip participants with **legal knowledge and analytical tools to protect cultural property in armed conflict** by:

- Raising awareness of the importance of CPP for humanitarian practitioners and military personnel;
- Strengthening understanding of relevant legal frameworks;
- Improving knowledge of military responsibility and accountability for violations of international law;
- Addressing operational challenges such as marking, targeting, and trafficking, and exploring new technologies to overcome them;
- Promoting civil-military cooperation;
- Highlighting the connection of CPP to peace processes and transitional justice;
- Encouraging collaboration among professionals across sectors and countries.

## Background

Cultural heritage forms a vital part of the collective memory, identity, and values of communities.

In the event of armed conflict, heritage faces significant risks, not only from **incidental harm** such as collateral damage or looting but also from **deliberate attacks** aimed at erasing a population's connection to its history.

Recognising the universal importance of cultural heritage for fostering peace, **international law has developed and evolved to protect it during armed conflict**. This legal framework is reinforced by best practices from military and civilian actors.

By adapting such tools to safeguard cultural property, stakeholders contribute to a more **comprehensive and sustainable approach to the conduct of hostilities, conflict resolution and post-conflict recovery**, while preserving invaluable testimonies of specific communities and humanity at large.
